VI.4.3. Review procedure

Precise information on deadline(s) for review procedures:

Remedies according to § 160 GWB:

- 1) The public procurement tribunal initiates a review procedure only on request;
- 2) Any company that has an interest in the public contract or the concession and claims an infringement initiates rights pursuant to Section 97 (6) GWB by non-compliance with transfer regulations shall have the right to apply. It must be stated that the alleged damage to the procurement rules has caused or threatens to harm the company,
- 3) The application is inadmissible insofar as:
 - the applicant has recognized the alleged infringement of public procurement rules prior to the submission of the request for review and has not complained to the contracting authority within a period of 10 calendar days, the expiration of the period according to § 134 paragraph 2 GWB remains unaffected,
 - infringements of procurement rules that are identifiable as a result of the notice of notice are not reported to the client at the latest by the end of the period for the application or the submission of tenders stated in the announcement,
 - infringements of public procurement rules, which can only be identified in the tender documents, are not claimed by the client at the latest by the deadline for the application or the submission of tenders,
 - more than 15 calendar days after receipt of the notification of the contracting authority to refuse to remedy a complaint have passed.

Sentence 1 shall not apply in the case of an application for the ineffectiveness of the contract pursuant to § 135(1) number 2. § 134 (1) sentence 2 shall remain unaffected.
