Description: Tuomi Logistiikka Oy kilpailuttaa uudelleen Steriilien suojakäsineiden osa-alueet 1-2 Sisä-Suomen yhteistyöalueen hyvinvointialueiden; Etelä-Pohjanmaan, Kanta-Hämeen, Pirkanmaan hyvinvointialueet; alueelle. Steriilit suojakäsineet osa 2 hankinnan kohteeseen kuuluu lateksi, synteettiset ja ohuet leikkauskäsineet. Steriileistä kaksoiskäsineistä tehtiin hankintapäätös 6/2026 edellisessä Steriilien suojakäsineiden kilpailutuksessa (Cloudia numero 610382). Tällä hankintasopimuksella hankintoja tekevät Tuomi Logistiikka Oy sekä Tavarantilaaja: Etelä-Pohjanmaan hyvinvointialue. Tilaaja voi tällä hankintasopimuksella tehdä tavarantiloja itselleen ja hankintalain mukaisille sidosyksiköilleen.
