Im Kreisberufsschulzentrum in Schwäbisch Gmünd soll eine Schadstoffsanierung, Generalsanierung und Erweiterung des Hauptgebäudes aus dem Jahr 1972 durchgeführt werden. Es handelt sich um ein 2-geschossiges Schulgebäude mit einer teilweise ausgebauten Unterkellerung und einer Bruttogrundfläche von insgesamt ca. 25 100 m². Die Generalsanierung soll in 4 Bauabschnitten durchgeführt werden. Die Planung sieht vor, dass mit der Generalsanierung im Juni 2019 begonnen werden soll. Die Baufertigstellung ist für 2023 geplant. Parallel zur Sanierung des Bestands sollen auf der Nord- und auf der Ostseite des Hauptgebäudes im Erdgeschoss jeweils eingeschossige Erweiterungen mit einer Gesamt-Nettogrundfläche von ca. 1 330 m² erstellt werden.
