Together the group shall map the stresses that all the objects in the existing Viking Ship house can have been exposed to. Both as regards construction work on the site and for any relocation. Furthermore, the collection's resilience as regards these stresses shall be assessed. Systems shall be designed to support and insulate objects that require protection from vibrations. Dust, temperature and humidity must also be assessed and if necessary measures must be designed to ensure secure, stabile climatic conditions.
