### **II.2.1. Total quantity or scope**

The assignment consists of weekly boat transport of residue waste, paper, glass and metal packaging and hazardous waste from Lindøya, Nakholmen, Bleikøya, Heggeholmen and Marineservice AS. This is divided between the islands in Inner Oslo Fjord, total seven 8 m<sup>3</sup> containers and four 180 liter sacks for residue waste, two 8 m<sup>3</sup> containers and two 4 m<sup>3</sup> containers for paper and four 4 m<sup>3</sup> collection units for glass and metal packaging. In addition there will be one environment station for hazardous waste located on Lindøya. The environment station includes several minor collection units on wheels that are transported by sea when needed.

The assignment is to be carried out in the summer seasons 2015 and 2016.
