Tillsyn, skötsel och underhåll av utemiljön är högt prioriterat för att upprätthålla trivsel, ordning och tillgänglighet för stadens invånare och besökare. Syftet med entreprenaden är att utnyttja utförarens kompetens för att, med utgångspunkt i ställda funktionskrav, utföra tillsyn, skötsel av plaskdammar, duschar och vattenanläggningar på parkmark inom stadsdelsförvaltningar i Stockholms innerstad.
