Other justification: This extension is requested for the repetition of similar services as included in the original contract. The amendment through a negotiated procedure extends the contract budget to the maximum allowed, which corresponds to an additional EUR 1,828,300 and an additional duration of 36 months. The repetition and continuation of similar services are necessary to ensure uninterrupted technical assistance and sustained coordination among communication actors in the Turkish Cypriot community. Maintaining this continuity is crucial at a time when stakeholder trust, inter-project collaboration, and visibility momentum have been firmly established but still require consolidation. This extension is possible in line with the contract notice of the initial project which states in Article II.2.14) Additional information as follows: "Subsequent to the initial contract resulting from the current tender procedure, new services or works consisting in the repetition of similar services or works, up to the estimated amount of 100%, may be entrusted to the initial contractor by negotiated procedure without prior publication of a contract notice, provided the new services or works are in conformity with the same basic project."
