Het OWI-Lab investeert in test- en meetinfrastructuur voor onderzoek en innovatie in de offshore wind energie. Zo werd in 2012 een grote klimaatkamer in Antwerpen in gebruik genomen voor het testen van grote componenten van windturbines. Sindsdien werden meerdere testcampagnes uitgevoerd op verschillende componenten. Omdat er heel wat onderzoeksvragen geïdentificeerd zijn over het gedrag, het ontwerp en de controle van windturbine tandwielkasten bij extreme temperaturen, wil het OWI-Lab een specifieke tandwielkast aankopen die zal toelaten om dit onderzoek te materialiseren.
