Explanation:

Het leerlingenaantal van de ISK Wereldschool is, o.a. vanwege de komst van Oekraïense leerlingen, onverwacht gegroeid van 70 leerlingen naar 220 leerlingen. Het leerlingenaantal van de school kent grote fluctuaties. Het is onmogelijk om voor dit onderwijs een leerlingenprognose te maken. De school heeft in verband met de groei met ingang van het schooljaar 2023-2024 13 extra lokalen nodig. Omdat de huisvesting van de ISK Wereldschool was doorgedecentraliseerd diende het schoolbestuur de uitbreiding met deze lokalen zelf te regelen. Omdat dit niet lukte heeft de gemeenteraad eind op 25 mei 2023 besloten om de zorgplicht terug te nemen. Met een herschikking van onderwijsruimte en om te voorkomen dat er met ingang van het nieuwe schooljaar voor groepen leerlingen geen onderwijshuisvesting beschikbaar is, is met spoed de plaatsing van 4 tijdelijke lokalen geregeld.
