De opdracht omvat twee percelen die elk de organisatie van een ondernemingsplanwedstrijden inhouden. Het brede publiek omvat alle personen die tenminste 18 jaar zijn en dus ook studenten met een ondernemersidee. Perceel 2 omvat de organisatie van ondernemingsplanwedstrijden gericht op leerlingen in het secundair onderwijs.
