Zamawiający wyznacza krótszy termin składania ofert, ponieważ zachodzi pilna potrzeba udzielenia zamówienia. Uzasadnieniem jest fakt kończących się rezerw z umów zawartych w wyniku przeprowadzonego postępowania w roku 2021 na leki objęte niniejszym postępowaniem, które były szacowane do wykorzystania na cały rok 2022. W przypadku pacjentów objętych chemioterapią nie można przewidzieć dokładnego zapotrzebowania z dużym wyprzedzeniem. W ostatnim czasie w szpitalu nastąpił wzrost liczby pacjentów objętych terapią onkologiczną a na podstawie analizy bieżącego wykorzystania poszczególnych leków istnieje wysokie prawdopodobieństwo, że zapewnione w umowach rezerwy na dane leki na rok 2022 wkrótce się skończą. Pod opieką szpitala przebywają również pacjenci wymagający nowych leków, nie będących w zasobach szpitala. Zachodzi więc uzasadniona konieczność zabezpieczenia zakupu leków, które są niezbędne do kontynuacji leczenia pacjentów naszego szpitala, zwłaszcza tych poddanych chemioterapii.
