Description: Objet des services : curage de réseaux d'égouttage par hydrocurage mécanique suivi d'une inspection télévisuelle par la technique dite du « chariot mobile ». Ces opérations seront réalisées sur l'ensemble des réseaux d'égouttage. Lieu de la prestation du service : les réseaux d'égouttage à investiguer sont ceux de l'agglomération épuratoire d'Athus (communes d'Aubange et de Messancy). Dans ce périmètre, le présent marché est divisé en trois lots. Des opérations de recherche et de dégagement de chambres de visite devront être menées. En effet, il est fort probable que certains tampons équipant les chambres de visite ne soient pas directement visibles et soient recouverts totalement ou en partie (feuilles mortes, terre, pelouse, tarmac, ...).
