Description of changes: By means of this rectification, SURF amends the Dynamic Purchasing System for Online Collaboration Tools and the associated procurement documents. The possibility of expanding the scope of the DPS with new categories was deliberately and explicitly provided for in the original procurement documents. Section 1.4.4 of the Admission Guidelines (review clause) states that the scope and content of the assignment may be changed if a new category is added to the DPS, and section 1.4.2 provides that, in the event of such a significant change, SURF will post a rectification on TenderNed. The addition of the category Community software constitutes a logical expansion of the existing scope: it concerns software solutions that fit well within the overarching term 'online collaboration tools' and serve the same participants and purpose as the existing categories. The nature of the DPS therefore remains unchanged. In accordance with the above, the following amendment was made: expansion of the scope with the category Community software; inclusion of an additional category set-up phase of thirty (30) calendar days for the new category; These amendments have no effect on requests for tender already published, on ongoing assignments, or on the position of candidates already admitted to the existing categories. Full details are set out in Addendum No. 2 (Rectification) and the amended Admission Guidelines (version 3.0), available via the Merzell procurement platform.
