#### **II.2.1. Total quantity or scope**

The contracting authority reserves the right to add all types of works described in chapter D1; Description, to each contract.

The scopes will be stated in the contractor's engineering design for each measure. The contracting authority will mainly execute the maintenance work in stretches.

The works will include, amongst other things:

Reinforcement in the form of deep stabilisation and replacement of masses Edge reinforcement

Trench work, Subdrains Supporting walls

Concrete structures Foot and Cycle paths, Crossing repairs Road lighting

Roundabouts Asphalt works, etc

The contracting authority will describe the design in accordance with N100, whilst the contractor shall design execution in accordance with N200, etc.

The tender contest does not contain information of scopes. The contractor must note that all price posts are cost objective.

The size of the contract is based on previous funding figures. The value of funding each year will vary.

The contract value is between NOK 0-50 000 000 the first construction year, and NOK 0-50 000 000 the second year if the contracting authority triggers the option.

#### **III.1.1. Deposits and guarantees required**

C1 point 8: Unless otherwise agreed upon, the contractor shall present a safe guarantee for the compliance of his contractual obligations. The guarantee amounts to 10 % of the contract value during the execution period. The guarantee will then be reduced by 3 % of the contract value for the first 3 years of the claim period. The contracting authority is not required to pay any allowance until having received the tender's security.

C2 point 12: Security shall be furnished by a bank, insurance company or other financial institutions, approved by the contracting authority. Accepted security includes the guarantee amount placed in escrow for the benefit of the contracting authority. Interest accrues to the contractor.

For working partnerships, security shall be provided on behalf of the working partnership, not the individual participating companies.

The contractor shall provide the builder with documentation of the collateral contract before the start of work and not later than 28 days after the contract is signed.

The Builder will not provide any security.

Tenderers are required to have positive equity. If the tenderer is a working partnership (supplier consortium), the requirements apply for each of the participants.

The tenderer's annual average turnover should be at least as large as the annual revenues the contract will generate.

The tenderer shall have experience from work of the same nature and degree of difficulty. By 'same nature and degree of difficulty', we mean that the contractor has been responsible for equivalent road works listed in A3, chapter 1. Here this means that the contractor shall have experience and competence with engineering design according to road standards, or have experience in associating themselves with such expertise. Engineering design competence requirement is not a part of the award criteria

Documentation requirement:

Information on such shall be attached with the tender. Cf. chapter E2, point 4.1.1, form E2-4.1.1.

Where the tenderer is dependent on a sub contractor in order to be qualified, the tenderer must document for the contracting authority that the tenderer will have authority over the required resources. This can be documented by the tenderer presenting a mutual statement of liability, or equivalent.

The tenderer is required to show references to relevant contracts that they themselves have carried out in a satisfactory manner. NPRA and other builders' experiences with the tenderer will be appraised

Conditions which will be evaluated are related to, a.:

- documentation of completed quality
- fulfilment of contracts
- compliance with provisions and procedures for HSE
- compliance with provisions for wages and working conditions
- observance of deadlines
- follow up during the warranty/claims period
