Nature and extent of the modifications (with indication of possible earlier changes to the contract):
Extend the framework to 31st March 2024. Framework rates will increase by 44%. These rates will be effective from 23rd September 2023 until 31st March 2024. The variation relates to Regulation 72 of the Public Contracts Regulations 2015 PCR 2015 clause 72(1)(b).
