Recently, the University of Twente has started a tender-procedure for the purchase of an electron beam lithography system (T217278 European Tender Electron Beam Lithography system). Unfortunately, we have realized that the Descriptive Document contained several (minor) short-comings. More specific, in the revised Descriptive Document a time-slot for site-inspection is included, as well as a correct textual description of the weighting of the three award criteria is inserted at the end of section 4.2 (viz. 70% (wishes; G1), 10% (sustainability; G2) and 20% (price; G3)). In appendix B Schedule of Requirements and Wishes – the subsection regarding ‘(extended) warranty’ has been removed (table P) and added to the maintenance subsection (see item O.2 in table O).
