Explanation:

The framework service contracts EPSO/EUSA/PO/2013/063 entered into force on 11.2.2015. The volume announced in the tendering documents was 2 675 man-days. Consumption of the services of the framework contract was higher than expected (linked for example to the migration crisis, etc.) and the initial ceiling is likely to be reached before the expiry of the initial framework contract. The tender specifications of framework contract EPSO/EUSA/PO/2013 /063 mentioned in point 6 the possibility of a negotiated procedure without prior publication of a contract notice for similar services during the 3 years following the conclusion of the initial contract. The contract amendment increases the initial budgetary ceiling by the amount indicated in point II.1.7).
