1. Wykonawcy w toku postępowania o udzielenie zamówienia publicznego przysługują środki ochrony prawnej przewidziane w ustawie z dnia 29.1.2004 Prawo zamówień publicznych (tekst jedn. Dz.U. z 2018, poz. 1986 późn. zm.).
