Päivystyskuljetukset, joissa vainaja siirretään sijaintipaikalta vainajien säilytystilaan tai suoraan ruumiinavauspaikkaan. Huom! Kuljetus suoraan ruumiinavauspaikkaan on poikkeustapaus. Edellisellä sopimuskaudella tällaisia poikkeustapauksia on ollut arviolta 1-2 kertaa vuodessa. Edellisellä sopimuskaudella päivystyskuljetuksia on ollut n. 180 kpl vuodessa (n. 15 kpl kuukaudessa).

Kuljetuksen tulee sisältää poliisin tai terveydenhuollon toimista johtuva odotusaika.
