Daarnaast worden veel bekappingsmaterialen ingebouwd en soms ook op maat gemaakt in onze voertuigen. Een verandering van leverancier vergroot het risico op een niet efficiënt ingerichte bekapping waardoor uiteindelijk niet alle bekappingsmaterialen ingebouwd kunnen worden. Mede door bovenstaande motivatie acht de VRR het proportioneel om een maximale looptijd van 10 jaar te hanteren.
