II.1.4. Short description

The invitation to tenders concerns the delivery of clearing, sanding, salting of fire pits, clearing and other winter maintenance on county and municipal roads and places at Skjånes. The contract value is estimated to be above the EEA threshold. The need is uncertain. Historically, the contracting authority has procured services for approx. NOK 1,450,000 excluding VAT a year in recent years. The volume can be both higher and lower, and will depend on, amongst other things, the contracting authority's needs, activities, budgetary situation and other framework factors in the contract period.

The contract has two lots: 1: County roads, and 2: Municipal roads The tenderer cannot submit tender for one lot, cf. section 1.1.4 below.
