Dit bestaat onder andere uit de aanbodverplichting van verschillende leerroutes aan alle inburgerende asielstatushouders. Dit betekent dat deze aanbesteding over het inkopen van de verschillende leerroutes gaat voor de asielstatushouders (inburgeraars).
