Description: Naručitelj je sukladno članku 284. st.4 i st.5. ZJN 2016, u dokumentaciji za nadmetanje naveo relativni značaj koji pridaje svakom pojedinom kriteriju povezanom s predmetom nabave, te se ponderira kriterij Pristupna informacijsko-komunikacijska mreža uzimanjem u obzir od ponuditelja potvrđenih i/ili dokazivih relevantnih podataka. Pristupna IK mreža važan je kriterij kojim se vrednuje dostupnost i neprekidnost usluge za Naručitelja. U administrativnom smislu Naručitelj ima svoje gradske urede, institucije i ispostave te u poslovno-procesnom smislu aktivno surađuje i komunicira sa drugim institucijama na cijelom teritoriju RH. Posebno je važno naglasiti nužnost visoke razine kvalitete pristupne IK mreže Naručitelja u kontekstu činjenice da Naručitelj djeluje u iznimno složenim organizacijskim uvjetima, u potpunosti je svakodnevno vezan za predmet ove nabave te snosi odgovornost za pouzdanost i sigurnost komunikacije kao esencijalne potrebe u cilju pružanja pravodobnih informacija i pomoći vlastitim klijentima. Svaki zastoj u redovnom radu bio bi uzrok neiskazivoj šteti i poremećaju u funkcioniranju regionalnog sustava kojem Naručitelj pripada, što se smatra izravnim i nenadoknadivim gubitkom za grad, županiju a time i građane Republike Hrvatske. Element kriterija odnosi se na izražavanje kvantitativnog pokazatelja kojim se vrednuje kvaliteta pristupa Naručiteljevih lokacija prema nepokretnoj elektroničkoj IK mreži Ponuditelja u kontekstu tehničkih karakteristika prijenosnog medija. Naručitelj preferira realizaciju pristupa za svoje lokacije svjetlovodnim fizičkim medijem. Ključni razlozi zbog kojih Naručitelj preferira svjetlovodni medij u odnosu na sve ostale prijenosne medije: 1. svjetlovodni medij može prenositi signal na puno većim udaljenostima nego bilo koji drugi fizički medij, 2. svjetlovodni mediji, u usporedbi s ostalim prijenosnim medijima, ostvaruje najveću propusnost i stabilnost u prijenosu i nije osjetljiv na atmosferske prilike (ta činjenica je posebno važna prilikom elektromagnetskih pražnjenja uzrokovanih čestim grmljavinskim nevremenom), 3. s aspekta sigurnosti prijenosa podataka fizički medij je najsigurniji prijenosni medij Preferiranje navedenog prijenosnog medija s korisničkog aspekta osigurava Naručitelju povećanu stabilnost poslovanja i komuniciranja, veću razinu sigurnosti u prijenosu podataka, znatno manja oštećenja krajnje opreme uzrokovano elektromagnetskim pražnjenjima, te skalabilnost poslovanja. Naručitelj je kao optimalan broj svojih lokacija spojenih na IK mrežu Ponuditelja svjetlovodnim fizičkim medijem definirao 70 lokacija i to na temelju trenutnog stanja odnosno to je postojeći broj lokacija Naručitelja koje su spojene na IK mrežu svjetlovodnim fizičkim medijem. Pri tome se smatra da je korisnikova lokacija spojena svjetlovodnim medijem na IK mrežu ukoliko se sve usluge na predmetnoj lokaciji realiziraju putem svjetlovodnog prijenosnog medija. Za Naručitelja je optimalna (najmanja) očekivana vrijednost 70 pa na više.
