Justification for the accelerated procedure: Na podlagi četrtega odstavka 40. člena ZJN-3 je naročnik zaradi izkazane nujnosti skrajšal rok za prejem ponudb na najmanj 15 dni. Pogoji za uporabo skrajšanega roka so izpolnjeni, saj nujnosti ni bilo mogoče predvideti, razlogi zanj pa niso posledica ravnanja naročnika.
