1. Tiekėjas turi teisę pateikti pretenziją perkančiajai organizacijai, pateikti prašymą ar pareikšti ieškinį teismui (išskyrus ieškinį dėl pirkimo sutarties ar preliminariosios sutarties pripažinimo negaliojančia ar ieškinį dėl pirkimo sutarties nutraukimo pripažinimo nepagrįstu):

- 1) per 10 dienų nuo perkančiosios organizacijos pranešimo raštu apie jos priimtą sprendimą išsiuntimo tiekėjams dienos, o jeigu šis pranešimas nebuvo siunčiamas elektroninėmis priemonėmis, – per 15 dienų nuo pranešimo išsiuntimo tiekėjams dienos;
- 2) per 10 dienų nuo paskelbimo apie perkančiosios organizacijos priimtą sprendimą dienos, jeigu šiame įstatyme nėra reikalavimo raštu informuoti tiekėjus apie perkančiosios organizacijos priimtus sprendimus.
