The project will upgrade its infrastructure and equipment, including one medium technical firefighting vehicle, one mobile command vehicle, one grapple truck, and 13 off-road pickup vehicles (12 for municipalities and one for the National Training Centre in Podgorica). These enhancements are essential due to the rising number of technical interventions, particularly during the busy tourist season, where high traffic and complex terrain, including tunnels, require swift emergency responses.
