De gemeente Heerenveen betreurt de aldus ontstane situatie en veroorzaakte paniek en biedt hiervoor verontschuldigingen aan.

De gemeente Heerenveen heeft besloten om de procedure TN 412422 vroegtijdig te beëindigen en – uitsluitend als herstelmogelijkheid - een nieuwe procedure te starten, zodat Aanmeldingen toch via TenderNed kunnen worden ingediend.
