Procedures for appeal:In accordance with Article 56 paragraph 1 of the Public Procurement Act (PPA), a written appeal against this decision can be lodged with the Federal Administrative Court, P.O. Box, 9023 St. Gallen, Switzerland, within 20 days of notification. Any appeal is to be submitted in duplicate and must include what is being sought, the grounds for appeal, evidence and the signature of the person lodging the appeal or his or her representative. A copy of this decision and available evidence must be included. The provisions of the Administrative Procedure Act (APA) on legal holidays do not apply in accordance with Article 56 paragraph 2 of the PPA.

Deadline / Remarks: Comment on the submission of tenders: place of submission see 1.2 above. General formal requirements, see specifications item 9.1.4. The tender without fail has to be closed and provided with the explicit remark «must not be opened – Invitation to Tender VW-499 Ghana 1». Delivery by traceable courier only. In all cases, the tenderer must ensure that it secures evidence that the tender was submitted on time. Any tenders submitted after the deadline will not be considered and will be returned to the tenderer.
