The objective of the procurement is to ensure the municipalities a uniform, efficient and predictable delivery of standard ICT equipment and the accompanying products for use in the municipalities' administrative activities, schools and other service areas. The framework agreement shall contribute to good commercial terms,

high security of delivery, good quality of products and services, as well as a reduced impact on the environment through emphasis on reuse and material recovery. The contract includes, among other things, the delivery of: Laptop and desktop PCs Chromebooks Monitors and docking stations Mobile telephones (iPhone and Android) Tablets (iPads and other tablets) Accessories and peripheral equipment for PCs, telephones and tablets The delivery shall also include associated services such as warranty, service and handling claims, as well as requirements for assembly and completion of products before delivery. The procurement will particularly focus on: Competitive prices, assessed through a price mark-up of defined product groups Environment considerations, including the tenderer's re-use and material recovery of scrapped ICT equipment, in accordance with the waste hierarchy Efficient and safe execution, including requirements for delivery time, guarantee, service apparatus and spare parts access The framework agreement has a duration of two (2) years + 1+1 years, with estimated and maximum values stated in point 2.2.
