— all disposable curtains meet should meet required British Standard BS 5867 Part 2 type BC,

— the Trusts do not require antibacterial coating on our disposable curtains. However if this is cost effective it will be considered as a variant bid. But this should be clearly stated within the pricing schedule,

— curtains should be in one piece without joins to ensure infection control measures.

The curtain gliders must be compatible within each trust and fit the currently installed rails, and must facilitate a rapid change over from a used curtain to a new replacement in less than 60 seconds. This will need to be demonstrated at the presentation which will be scored as part of the evaluation.
