RNHI is the project manager for the construction project, and is the property company that is responsible for the construction, hire, operation and maintenance of the building.

The building is approx. 16 200 m² gross, divided between 6 floors, with a car park and technical area in the basement.

The building will be handed over to the builder in January 2021 and it will open on 1 March.

The largest tenants in the building will be Alver Municipality, Helse Bergen HF, and Hordaland County c/o the County Dental Officer.
