Ejecutado el contrato anterior y a punto de terminar la última prórroga, las anualidades previstas no se ajustan a las necesidades surgidas, debido a lo siguiente: En el mes de julio de 2022, la Administración autonómica eliminó la Tarjeta Monedero dependiente de la Consejería de Política Social, la cual tenía la misma finalidad que este mismo contrato. Así, se aumentó la demanda de este servicio, impidiendo realizar una previsión real del gasto. Como consecuencia, el presupuesto disponible para terminar 2022 y enero de 2023 no es suficiente, aun tramitando una modificación del mismo. Dicho lo cual, se hace necesario adelantar la finalización del contrato al 31/12/2022 y no al 31/01/2023 como estaba previsto.
