Die Station ist Teil der A-Linie und besitzt jeweils am Anfang und am Ende eine Verteilerebene (-1-Ebene) sowie dazwischen zwei übereinander liegende Bahnsteigebenen (-2- bzw. -3-Ebene). Die Station verfügt über insgesamt 5 Zugänge, von denen der Hauptzugang am Ende der Lister Meile liegt und über eine markante, tonnenförmige Dachkonstruktion verfügt.
