Description: Das Kloster Jerichow (gegründet 1144/48) ist als frühester Backsteinbau nördlich der Alpen ein einzigartiges Zeugnis mittelalterlichen Technologietransfers. Seine Architektur spiegelt als steinerne Zeitachse die regionalen Umbrüche vom Mittelalter bis zur Moderne wider. Im Zuge einer Neukonzeption sucht die Stiftung ein integriertes Gestaltungs- und Leitsystem für eine neue Dauerausstellung. Aufgabe ist die szenografische Vermittlung der Klausurräume im Erdgeschoss sowie der Ausstellungsflächen im Obergeschoss des Ostflügels und im Malzkeller.
