Description: Hankinnan kohteena on ulkoisen liikennetiedon hankinta, jonka tavoitteena on ajantasaisten liikennetietojen ja niihin liittyvien tiedonkeruupalveluiden hankinta. Hankinnan piiriin kuuluvat erilaisin menetelmin kerättävät liikenteen sujuvuus-, olosuhde- ja tilannetiedot sekä näiden jalostamiseen tarvittavat palvelut. DPS on jaettu viiteen eri osa-alueeseen: 1. Nopeus- ja sujuvuustieto 2. Olosuhdetieto 3. Tiestön kuntotieto 4. Liikenteen turvallisuus - läheltä piti tilanteet ja äkilliset toimenpiteet 5. Liikennemäärätieto DPS mahdollistaa tilaajalle pitkäaikaisen ja jatkuvasti kehittyvän järjestelmän, josta se voi joustavasti hankkia kulloiseenkin tarpeeseensa markkinoiden uusimpaan teknologiaan perustuvia tietopalveluja. Toimittajien kannalta DPS mahdollistaa uusimpien innovaatioiden tarjoamisen sekä toimittajajoukon laajentamisen järjestelmän voimassaolon aikana. Varsinaiset tietopalveluhankinnat tilaaja toteuttaa dynaamisen hankintajärjestelmän sisällä erillisinä kilpailutuksina.
