Description: In this procurement, the award criteria for environment is not weighted by 30%. The Norwegian Public Roads Administration has determined that this procurement is exempted from the environmental requirement in the award criteria for procurements in the

procurement regulations § 7-9. This is because the procurement is considered to have an immaterial climate footprint and environmental impact, cf. the procurement regulations § 7-9 (5). The Norwegian Public Roads Administration shall procure licences for maintenance of the software portfolio from SAP Data Integrator. It should also be noted that the Norwegian Public Roads Administration shall only procure the actual service, and servers shall not be installed or in any way procured from the Contracting Authority as a part of this procurement. The service itself will have very limited climate footprint and environmental impact. The Norwegian Public Roads Administration cannot see other conditions connected to the procurement of maintenance that lead to a climate footprint or environmental impact. The terms for using the exception in the procurement regulations § 7-9 (5), and the contracting authority is, thus, exempt from setting award criteria relating to the environment for this procurement.
