Other justification: Vajalik on kiiresti sõlmida Taara linnaku konteinerite rentimiseks uus leping, kuna ettenägematult on selgunud, et kasutajad vajavad ruume vähemalt 3 kuud. Kuna kasutajate mittekolimine selgus ootamatult ning neid ei ole võimalik ka mujale majutada, siis on vajalik sõlmida 3 kuuks (pikendamisvõimalusega 3 kuuks) uus konteinerlinnaku rendileping kasutades selleks väljakuulutamisetähtaajaga läbirääkimistega hankemenetlust RHS § 49 lg 1 p 3 alusel. Kuna konteinerid on Taarasse paigaldatud Ramirent Baltic AS (10199349) poolt, siis on majanduslikult ökonoomsem sõlmida lühiajaline leping sama ettevõttega, kes suudab tagada kasutajate kiire vajaduse täitmise.
