- actively manage the demand for gynaecology services ensuring speedy access,
- reduce the number of patient visits via a coordinated seamless service user pathway,
- reduce waiting times for service users requiring treatment and assist in maintaining the standard of a maximum 18 week period from referral to treatment,
- improve service user experience,
- ensure service users are seen and treated in a safe environment most appropriate to their needs,
- work to locally agreed models of care and pathways for gynaecological conditions.
