who have cognitive impairment and / or a diagnosis of dementia. There may be a need for reinforced nursing and care services, increased requirements for medical supervision, shielding, maintenance of functional level and any rehabilitation.

The contract can also be used by other municipal entities, including all governmental bodies and coalitions established by one or more of these municipalities.

The framework agreement will apply for Lunner and Jevnaker Municipalities. Option for Gran Municipality to enter into the framework agreement if required.

The framework agreement will be valid for two years with an option for an extension for one year at a time to a total length of maximum four years.
