Justification for the duration of the framework agreement: De looptijd van de opdracht overschrijdt de limiet van 48 maanden. Rechtvaardiging: Het doel van de aanbesteding is om in de eerste 4 jaar de vernieuwingsaankopen te doen en in de rest van de looptijd (1 jaar) de aankopen te beperken tot sporadische aankoop, behoudens perte-totales en verplichte verduurzaming van overheidswege. Door te werken met een raamovereenkomst van 6 jaar wordt er een identiek type/merk voertuig gegarandeerd met eenzelfde bediening voor de roterende bemanning binnen de verschillende kazernes van Brandweer Zone Antwerpen (BZA). Deze wagens worden steeds hoogtechnologischer, en het schakelen tussen verschillende merken met eigen filosofieën is hierdoor onhaalbaar geworden, en zal een hypotheek leggen op de operationele paraatheid van BZA. Ook duurt het telkens enige tijd om alle personeelsleden op te leiden en vertrouwd te laten raken met de werking van een type voertuig, met de nodige opleidingskosten die hieraan verbonden zijn. Een verandering van type voertuig na 4 jaar is daarom niet wenselijk, noch kostenbewust.
