Reason for modification: Need for additional works, services or supplies by the original contractor.

Description: The contract modification is necessary due to updated requirements from ITER IO, particularly SDR #956, which introduces additional scope. A change of contractor is not feasible due to interconnectivity with the scope awarded in the initial specific contract (Art. 85f (4)(a) F4E FR). The services are already partially delivered and changing the contractor at this stage will result in duplication of work and delays. The current contractor, ranked first based on a balanced technical and financial evaluation, is likely to provide the most cost effective offer for this additional scope. Switching contractors would represent a significant inconvenience for F4E. The additional scope of work does not alter the subject matter of the contract. Its value is well below 50% of the original contract value.
