Muiden verhoiltavien irtokalusteiden toimitus ja asennus tulee aloittaa 8 viikkoa sitovan tilauksen jälkeen siten, että kalusteet ovat valmiina käyttökuntoon asennettuna 9 viikkoa sitovasta tilauksesta, mikäli muuta ei sovita.
