Description of selection criterion: Tenderers are required to have satisfactory financial implementation ability. The size of the turnover, one in relation to the contract value, can be emphasised. Documentation requirements: The Directorate of Public Construction and Property will carry out a credit rating of tenderers. Tenderers may, in addition, be asked to submit auditor confirmed annual accounts, alternatively state StartBANK ID.

Description of selection criterion: Tenderers shall have secure implementation ability (capacity). Documentation requirements: Overview of the number of employees in the company, divided into job categories. The overview shall show the tenderer's relevant manpower within the relevant discipline.
