De Regionale Scholengemeenschap (RSG) Wolfsbos vormt het bestuur van een brede scholengemeenschap met op dit moment 5 schoolgebouwen, gevestigd op één schoollocatie voor Voortgezet Onderwijs in de gemeente Hogeveen. Er is gekozen om Wolfsbos te huisvesten in een nieuw gebouw, gepositioneerd in de nabijheid van het enige gebouw wat nog voor de lange termijn gehandhaafd blijft: De Meander.

De nieuwbouw van RSG Wolfsbos zal worden gerealiseerd voor 1228 leerlingen. Bij dit leerlingaantal hoort een permanente ruimtebehoefte van 10.815 m² bruto vloer oppervlakte (bvo) exclusief gymcapaciteit (à 1.024 m²), 803 m² wordt ingevuld door het gebouw de Meander waarmee de nieuwbouw een volume kent van 10.012 m².

Er zullen tevens twee nieuwe gymzalen gerealiseerd worden.
