The current creosoted wood poles framework in place since mid-2019 has two current suppliers. Recently both suppliers have confirmed to ESB Networks that due to ongoing supply chain difficulties they are unable to deliver the quantities requested for deliveries in 2023. Analysis of the impact of this shortfall has indicated that this may result in temporary suspensions / slowdowns in some of our major PR5 programs and New Business for some months and a risk that contractors would seek alternative work outside ESB in the interim and be unavailable to complete these work programs when supplies are eventually received.
