The embassy of the Kingdom of Netherlands with which a MoU was signed in June 2020 would like to end its security service contract. A first end date was set for 30 April 2023. They refuse any change to the current conditions (i.e. we cannot downsize the security team despite being oversized and very expensive) and we are therefore obliged to sign a framework contract directly with the local contractor. An extension until 1 July 2023 is under discussion (favorable opinion). It is therefore necessary to quickly set up a direct contract with the company currently in charge of this service.
