Average speedometers with and without video recorders for fixed installation in patrol vehicles. Including a need to supplement and complete available instruments for vehicles and motorcycles. The current average speedometers use sensor-based technology for measuring distance over time, either from the vehicle's own sensors or external sensors. These systems are installed in patrol vehicles or motorcycles to calculate the average speed over a given distance. The Norwegian Police Shared Services (PFT) has carried out a RFI on behalf of the Norwegian police for average speedometers with and without video recorders for permanent mounting on the Norwegian Police's vehicles. Cf. Doffin reference 2023-695548 and TED reference [2023/S 054-158192](#). The purpose of the RFI was to receive an update from the market on relevant products and potential suppliers that can cover the police's need for this product area. The RFI only found one supplier that can cover the current need. See the voluntary ex-ante transparency notices 2023-651457 and [2023/S 209-659376](#).

The Norwegian Police Shared Services (PFT) has carried out a RFI on behalf of the Norwegian police for average speedometers with and without video recorders for permanent mounting on vehicles. Cf. Doffin reference 2023-695548 and TED reference [2023/S 054-158192](#). The purpose of the RFI was to receive an update from the market on relevant

products and potential suppliers that can cover the police's need for this product area. Responses to the RFI and the contracting authority's other information of the market indicate that there is currently only one supplier that can deliver and cover the need for supplementing and completing the instrument park of average speedometers with and without video recorders for the Norwegian Police's cars and motorcycles. The police currently has a framework agreement with Palmenco AB for average speedometers with and without video for fixed installation in vehicles/on MCs. The framework agreement is expected to be renewed for up to 2 years from 11.02.2024. There was also a voluntary ex-ante transparency notice in accordance with the public procurement regulations §21-5, cf. notices 2023-651457 and [2023/S 209-659376](#),. No objections were received regarding the signing of the contract. As only one supplier can meet the need, the conditions for procurement without a call for tender in accordance with the PPR §13-4 b) 2 are considered fulfilled.
