Main features of the procedure: The aim of the procurement is to enter into a framework agreement with a tenderer for printing services, profile articles and trade fair materials. The procurement shall i.a. include the preparation of print files and printing of forms (forms), brochures, folders, posters etc. in addition "printing as needed" (print on demand), as well as other printing services. The procurement also includes profile articles, trade fair material and simple graphical design connected to the services. The estimated value is NOK 6-7 million excluding VAT for the four year period. The maximum total value of the framework agreement is NOK 8.5 million excluding VAT.
