Die Georg-August-Universität Göttingen betreibt eine aeroderivate Gasturbine des Herstellers General Electric Typ LM2500 SAC (Serial-Nr.: 481-771). Im Jahr 2012 wurden 91 000 MWhel bei 6 900 Betriebsstunden und 84 Starts erzeugt. Die Laufzeit der Gasturbine liegt zwischen 5 000 - 7 000 Bh pro Jahr. In den Jahren 2011-2014 waren ca. 60 h/Jahr Field Service Einsatz notwendig.
