Documentation requirement: 1. A list of up to 8 and not less than 3 contracts that the contractor has carried out or are carrying out during the last five years calculated from the deadline for submitting requests for participation in the competition. The minimum and maximum limit applies to the total number of reference projects, and is the same regardless of whether the tenderer fulfils the qualification requirement alone or relies on others to fulfil the qualification requirement. The listed reference projects shall together document fulfilment of the qualification requirement.
